The Administration Building was cleared for re-entry by Golder Ranch Fire Department at 5:30 p.m.


Mayor Hiremath reconvened the meeting at 5:33 p.m.

**MOTION:** A motion was made by Vice Mayor Waters and seconded by Councilmember Snider to adjourn the meeting at 5:35 p.m.


